



Transfer of Membership November 1, 2022 -October 31, 2023

A renter or guest is entitled to use the club facilities on the same basis as the designated member and is responsible for following all club rules and by-laws. **The designated member relinquishes their use of membership during the period their membership is transferred.**

EQUITY GOLF MEMBERSHIP TRANSFER

This membership entitles the renter use all the golf, tennis, fitness, and social facilities of the club. Golf Equity renters have a 7-day signup privilege to reserve golf starting times and 4-day sign up for tennis court reservations (no court fees). Renters do not pay green fees but are required to pay the golf cart fee or the golf cart transfer fee.

January 1 – April 30	\$800/month plus tax of \$52.00 = \$852.00
May 1 – September 30	\$400/month plus tax of \$26.00 = \$426.00
Oct 1 – December 31	\$650/month plus tax of \$42.25 = \$692.25

EQUITY SPORTS MEMBERSHIP TRANSFER

This membership entitles the renter use all golf, tennis, fitness, and social facilities of the club. Sport Equity renters have a 4-day signup privilege to golf tee times and court reservations (no court fees). Renters are required to **pay green fees** and the **golf cart fee or the golf cart transfer fee.**

January 1 – April 30	\$300/month plus tax of \$19.50 = \$319.50
May 1 – September 30	\$ 50/month plus tax of \$3.25 = \$ 53.25
October 1 – December 31	\$200/month plus tax of \$13.00 = \$213.00

Sports Equity Golf Greens Fees in addition to transfer fee:	November 1 – April 30	\$90
	May 1 – October 31	\$15

CART TRANSFER FEE \$185 per month plus tax of \$12.03 = \$197.03
(Cart fees are an additional expense of \$25.00 plus tax per person unless a cart transfer has been paid)

EQUITY SOCIAL MEMBERSHIP TRNSFER

This membership entitles the renter to use all the social facilities of the club including the fitness center, tennis courts, and all dining venues. Social members are limited to play golf 6 times, provided the member hasn't used his playing privileges. Social Equity renters are required to pay greens fees, and cart fees.

January 1 – April 30	\$100/month plus tax of \$6.50 = \$106.50
May 1 – September 30	\$ 50/month plus tax of \$3.25 = \$ 53.25
October 1 – December 31	\$ 75/month plus tax of \$4.88 = \$ 79.88

Social Equity Golf Green Fees in addition to transfer fee:	November 1 – April 30	\$100
	May 1 – October 31	\$20

The designated renter can only transfer a member's privileges a maximum of three years. (see Addendum for new rule effective May 16, 2017). Any amount of time less than a month, will be charged as pro-rated 1/2 month.

All membership transfers require a \$500.00 refundable deposit.

This deposit may be charged against during the designated guest's tenure. Upon departure, should the guest have a credit, this shall be forwarded to them. If not, the guest shall be responsible for additional balances due. The designated member is responsible for all unpaid charges.

*Sales tax rate is 6.5%
